### **Position Summary:**

The **Monitoring, Evaluation & Learning (MEL) Advisor** contributes his/her energy, passion, and skills primarily to supporting Seed's MEL efforts in the US and abroad, in a fast-paced office during a time of rapid growth. The position is a full-time position based in Boston, MA. The MEL Advisor leads operational MEL for the organization, providing technical expertise and managing the internal and external dissemination of learning. This full-time position reports to the Director of Monitoring, Evaluation and Learning and works closely with all US and field-based team members.

# **Duties and Responsibilities:**

Responsibilities include the following:

### **Operational Monitoring, Evaluation & Learning**

- Lead the design and development of an operational MEL system across Seed's portfolio of programming, aligned with Seed's program quality standards
- Develop indicators and tools for Seed's global programming to capture activities, outputs and emerging evidence of outcomes, ensuring consistency across countries and programming streams.
- Develop and support the implementation of monitoring systems that systematically track partnership activities and outputs, including training materials and integrating technologies as needed.
- Ensure Seed's partnership work plans have a robust MEL component and successfully execute MEL activities throughout the partnership life cycle including data collection, analysis, and reporting on

- key activity and output indicators, working in close collaboration with Seed staff and in-country partners.
- Compile, analyze, and share data, developing a knowledge base for improved understanding of Seed's programming.
- Provide technical guidance throughout the partnership lifecycle on monitoring efforts, data quality and collection protocols, and documentation of results.
- Assist in providing data for donor reporting requirements, ensuring MEL reporting requirements to donors are met.
- Support the development of new projects and proposals, in conjunction with the Director of Monitoring, Evaluation & Learning, to ensure quality MEL aligned with Seed's MEL standards and practices.

### **Dissemination of MEL findings**

- Lead dissemination of MEL findings for improved understanding of program results and to support evidence-based programming across the organization.
- Collaborate with Program Quality & Management team to facilitate learning around MEL findings.
- Develop and implement systems and/or platforms to share MEL findings and enhance the capacity of teams to actively monitor program progress.
- Develop training materials to facilitate productive use of dissemination systems/ platforms.
- Translate MEL data into infographic and summary formats that illustrate key findings for internal and external audiences.
- Develop and maintain portfolio of standardized MEL findings including documents, graphics and talking points.
- Identify solutions to gather, channel and store MEL-related information.
- Maintain internal access to data and summaries.

## MEL Intern Management, as needed

- Supervise interns to ensure quality and timeliness of deliverables.
- Ensure any external internship requirements are met (if applicable).
- Ensure a positive internship experience, providing mentoring and/or making connections with other Seed team members.

- Masters degree in a related area [social or behavioral sciences, public health, health services research, population health]
- At least 5 years of experience working with international development programming and MEL systems
- Experience in practically implementing MEL activities for a project or program in a low-resource setting
- Strong data collection, management and analysis skills (both qualitative and quantitative), with

- experience using R, SPSS and/or STATA preferred
- Proficient with Microsoft Suite and online survey platforms
- Data visualization skills and experience with data visualization software preferred
- Strong writing skills and ability to synthesize MEL findings into clear, concise summaries
- Excellent project management skills, experience in working with remote teams and on collaborative efforts
- Excellent ability to problem-solve and attention to detail
- Passion and commitment to Seed's mission
- Strong sense of accountability, personal initiative, and responsibility
- Excellent interpersonal skills, including flexibility and a sense of humor
- Demonstrated cross-cultural sensitivity and ability to build respectful relationships with colleagues from different cultural, linguistic, and educational backgrounds;
- Ability to work collaboratively in a fast-paced and young organization work environment
